The statement is to be typed or printed on a single A4 page, or if it is delivered electronically, is capable of being printed on a single A4 page. The statement is to include the candidate's name as the candidate wishes it to appear on the ballot paper and details of where and how he or she can be contacted and is to address any additional information that may be requested by the Board. The candidate may include a passport size photograph of the candidate's head or head and shoulders which must be recent and show a reasonable likeness of the candidate.
